### NEW BUSINESS

a. Solar Ordinance discussion.

A revised proposed zoning ordnance amendment was presented and reviewed. The proposed amendment was revised by the Township's attorney based on the Planning Commission's comments from the June 21, 2018 Planning Commission meeting.

After discussion, the following modifications were suggested:

1. Reduce the maximum output of small solar systems from "150 killowatts" to <u>"75</u> killowatts" and change the output of medium solar energy systems from "greater than 150 killowatts but not exceeding 1 megawatts" to "greater than <u>75</u> killowatts but not exceeding 1 megawatt".

2. Sections 13 and 14: Make minor changes in the order of sub sections/items for consistency and in order to alphabetize.

3. Sections 17 and 18: Make minor changes in subsection numbering to make the numbering consistent.

Motion by Warbritton and supported by Doerr to accept the proposed Solar Ordinance Amendment, with the above changes, and present the proposed ordinance at a public hearing at the next meeting. All ayes. Three absent. Motion carried.
